

Maintenance Of Effort

VDOE-The Virginia Department of Education (VDOE) under the Federal <u>Individuals with</u> <u>Disabilities Education Act</u> (IDEA) annually receives an allocation from the United States Department of Education (USED) to supplement existing local and state funding to serve students with disabilities. In turn, prescriptive allocation amounts are made available to each eligible Local Educational Agency.

Local Amounts(Estimated/Projected)

- Dollar-\$4,915,539.00
- Per Capita-\$8,345.57

Local Plus State (Estimated/Projected)

- Dollar-\$6,793,744.35
- Per Capita-\$11,534.37



Proportionate Set Aside

VDOE-Each LEA must expend, during the grant period, on the provision of special education and related services for the parentally-placed private school children with disabilities enrolled in private elementary schools and secondary schools located in the LEA ...

- Students are parentally placed in private schools or home schooled
- Total Eligible Fund Set Aside:
 - 2021-2022 SY \$21,516.16
 - 2022-2023 SY \$35,830.40
 - 2023-2024 SY \$37,139.70



Excess Cost

VDOE-The purpose of the federal requirement for excess costs calculation is to enable LEAs to determine the amount of regular education funds being expended on the basic education of its students with disabilities.







Exceptional Educational Factors To Consider •



- CCPS uses IDEA funds to cover a portion of needed special education positions
- In recent years, costs have exceeded the grant due to an increase in student population and the impact of disability that students have
- Funds carried over from previous years have funded the difference
- As student numbers and needs increase, one or more positions may need to move to local funding
- CCPS will monitor student enrollment and plan accordingly
