- Estimated completion will be week of April 7th

Finalize Options

- Requested RRMM to provide calculations to include inflation for outyears during design/construction phase
- Requested RRMM provide figures for "high growth" vs moderate growth
- Additional meetings to be held with Board of Supervisors

Explore Funding Options

- County Administration will be providing CCPS staff with potential funding streams
- Explore Literary Loans, Virginia Resource Authority, General Obligation Bonds
- Draft General Obligation Bond Timeline
